GA Report:

- CASA has released some short-term measures due to Covid-19.
 They have extended training certificates for six months.

 Flight reviews have been extended for three months from due date.
- Class 2 medicals can be done by any doctor with a \$10 fee due to CASA.
- Safety Seminars have been suspended.
- John reported that RAAus are now handing rego info to AvData so we will all be getting landing fees in the future.
- Paul Bennet Airshows are available for member viewing for free via the RAAus website.
- 2020 Wanaka air show in New Zealand was cancelled which affected a few members plans to go.
- John says RAAus feel pilots can fly to keep engine and licence current, provided they go solo or with their partner.
